#### Prime Minister's Youth Council

PEI's representatives on the Prime Minister's Youth Council, Chris Zhou and Dana Kenny joined the Youth Futures Council via video-call and in person, respectively.

Chris Zhou requested back in December an opportunity to meet the Youth Futures Council in hopes of learning more about the needs of young Islanders. Recently, Dana Kenny has been announced as an appointee stemming from the second wave of applicants. A discussion was held on what the PMO's Council is working on and what areas overlap with the work of the Youth Futures Council.

**Next Steps:** Explore opportunities to collaborate with the Prime Minister's Youth Council on future initiatives.

A pitch was made by a council member to work on a recommendation surrounding increasing co-op and experiential learning opportunities for post-secondary students.
